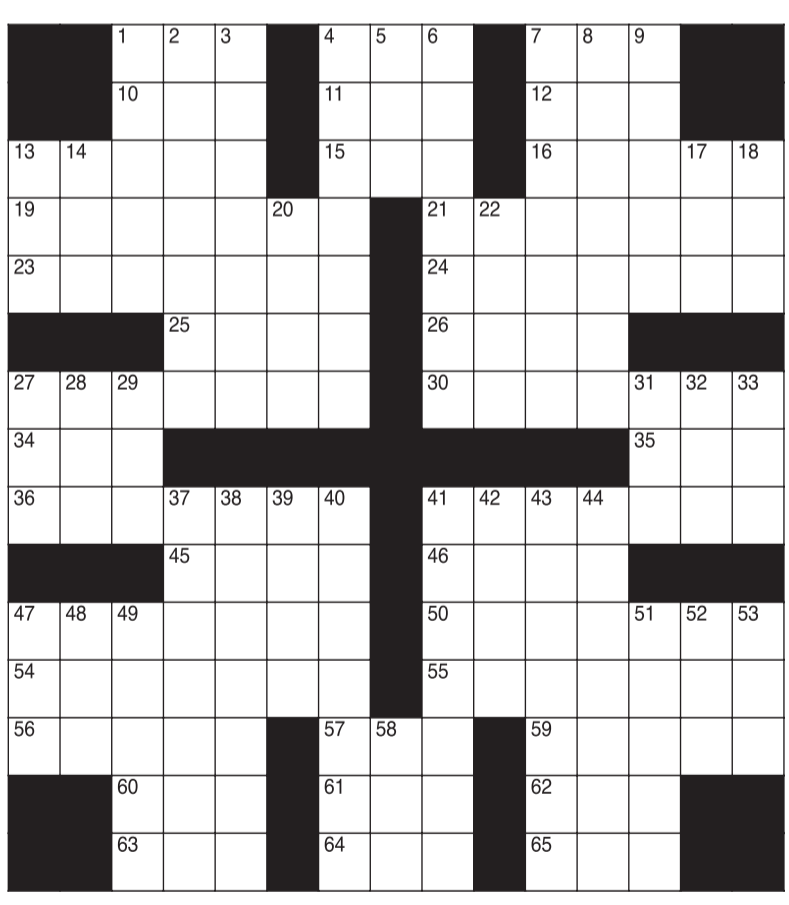

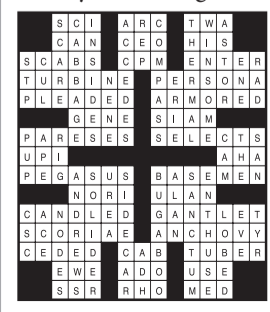

Project Description: An application for Conditional Use Permit (CUP 20-4) has been submitted to the City of Seal Beach. The proposed project consists of the installation of a new hydrogen fueling facility at an existing gasoline station and convenience store. The proposed hydrogen fueling station would be similar in construction and appearance to the existing gasoline fueling stations and would provide two new hydrogen fuel dispensers. The existing convenience store, fueling bays canopy, and associated gasoline fueling equipment would remain on site, as would the auto service and repair station attached to the convenience store. In addition, an approximately 1,010-square-foot hydrogen equipment enclosure would be constructed in the northern portion of the project site. The enclosure would be a four-sided wall/fence structure without a roof. The enclosure would be of decorative CMU construction and include steel screening fence along with steel doors or gates to restrict access. Hydrogen equipment in the enclosure would include two hydrogen station modules for gas compression, hydrogen gas storage vessels, and a delivery manifold for off-loading fuel deliveries. Underground fuel pipelines would be installed to carry the hydrogen to two dispenser pumps, which would be installed west of the existing fueling stations.

Environmental Effects: The City, as Lead Agency under CEQA, prepared an Initial Study of environmental impacts of the Project. Based on the findings of the Initial Study, the City has determined that the Project could result in potentially significant effects, but the Project Applicant will incorporate mitigation measures that would avoid or mitigate effects to a point where no significant environmental impacts will occur. Mitigation has been included to address aesthetics, air quality, cultural resources, geology and soils, hazards, land use and planning, hazards and hazardous materials, noise, transportation, and tribal cultural resources.
