The Draft EA evaluates the potential environmental effects associated with the relocation of 18 personnel and four UC-35A Cessna Citation Ultra aircraft to Joint Forces Training Base (JFTB) Los Alamitos. After relocation to JFTB Los Alamitos, the aircraft are estimated to have approximately 200 takeoffs and landings annually. The Proposed Action does not require construction, renovation, demolition, or land-disturbing activities.

The 63d RD prepared the Draft EA in accordance with the National Environmental Policy Act (NEPA) and regulations implementing the Act. The 63d RD intends to issue a Final EA and Finding of No Significant Impact (FNSI) following this 30-day comment period. Comments on the Draft EA will be summarized and addressed in the Final EA.

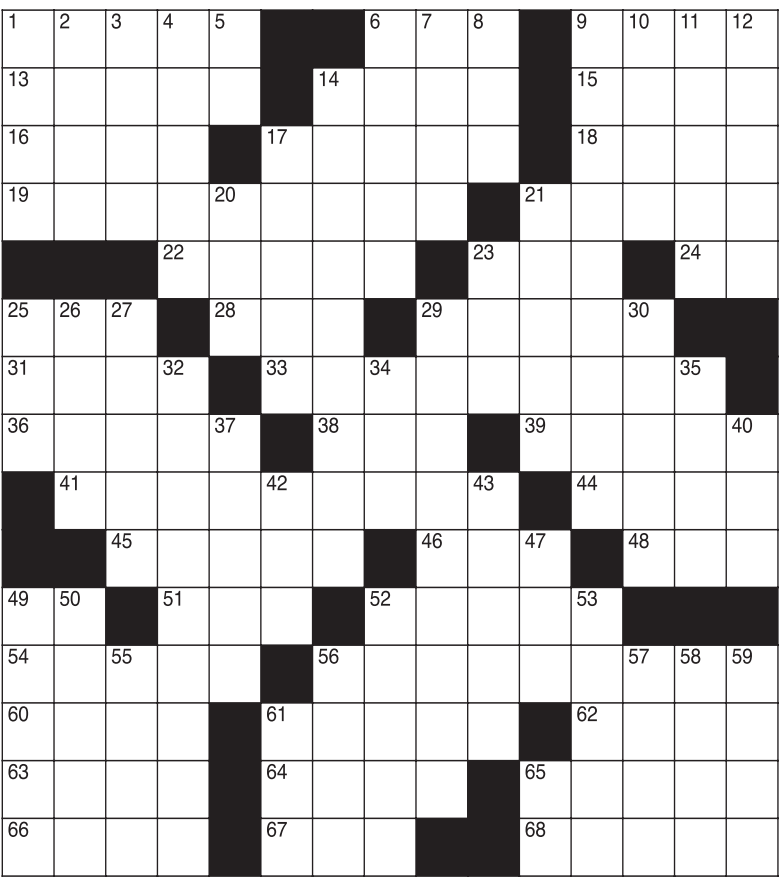
