It will also be available on the City's website, <https://www.sealbeachca.gov/>. Once on the City's home web page click the "2020 UWMP" button.

The public hearing is scheduled for June 14, 2021 at 7:00 PM, as a result of the COVID-19 emergency and the Governor's Executive Order to protect public health by limiting public gatherings and requiring social distancing, all participation in the above-referenced meeting will be via Zoom teleconference.
