These public hearings were held on December 13, 2021, February 15, 2022, February 22, 2022, February 28, 2022, and March 14, 2022. Notice of each redistricting public hearing was published in the SUN News paper pursuant to the requirements of Elections Code Section 21628(c); and WHEREAS, the boundaries of the City Council Districts established by the so-desig nated Official City Council District Map are contiguous, geographically compact, and provide all Seal Beach residents with fair representation on the City Council.
