Beginning January 1, 2022, SB1383 requires every jurisdiction to provide organic waste collection services to all residents and businesses. This will require residents and businesses within the Sunset Beach Sanitary to subscribe and participate in the District's three-container Organic Waste collection services, as do surrounding cities.
