## **Afterthought has become Seal Beach Classic Car Show**

The Seal Beach Classic Car Show made its debut on Main Street on April 1988, with around 50 classic vehicles sharing space on Main Street with hayrides, other children's rides, and vendor booths. But thanks to some vision, hard work and perhaps a little magic, it has grown into what's now billed as the largest beachside car show in Southern California.

The event was originally just an inducement by the Seal Beach Business Association to get more shoppers for the Spring Sidewalk Sale. In fact, at the time it was almost an afterthought, according to the man who started it all, Steven Bruce.

In late 1987, Bruce, a local financial planner, was the newly-elected President of the Seal Beach Business Association, a group that splintered off in the 1970s from the Chamber of Commerce to focus on Main Street/Old Town business issues such as their semi-annual sidewalk sale, an event that had been declining in popularity.

"At one of my very first meetings as president," recalled Bruce, "I pitched the idea of making the sidewalk sale more fun, more of a party, perhaps with a hayride, some food booths, and maybe even a car show. And then I said, 'and we'll also close down the street.' Oh, did that get a response – you can't do that! They won't let you."

Undeterred, Bruce went to the police and explained his idea. They and the city were fine – but because they would be closing "turn pockets" on PCH, a state highway, they had to get Caltrans approval. "It took a couple more weeks but we got the go ahead."

"I was a car buff - I had a Jaguar XKE – but the only thing I really knew about car shows was that Seal Beach cop Rick Paap had introduced me to another car guy named Bob French. French, who lived in Downey, owned a 1960 Lincoln Continental Mark V convertible was a performing comedian and magician, a card-carrying member of the Magic Castle, but he also promoted car shows. "Bob got some flyers printed and handed them out at other car gatherings and boom! we're in the car show business." French lined up some sponsors and even arranged to have some other cars brought in

besides his Lincoln.

Bruce lined up the Lions to host a pancake breakfast and then hot dogs and burgers for lunch. "And we also got volunteer help that day from some other local car guys."

Paap, who worked the show as a policeman for five years and as an emcee for another seven, remembers that first show well. "It was small – maybe only fifty cars – but everyone felt it was a success." So successful the Association decided to do include a car show at the Fall Sidewalk Sale. That event, held on October 3, 1988, attracted over 125 classic cars.

"That show went well, too," recalled Bruce. "But the spring show just seemed more fun, so we decided to just do the show once a

year in April." That decision forced Bruce to step back. "I do taxes, April is my busiest month, but I still helped out where I could – especially on show day. I loved the whole atmosphere, all the families and the moms resting with their kids on the sidewalks. The restaurants being busy. It was great."

While a Business Association member served as co-chair to work with the city and handle permits, French stayed on as the primary organizer, but he was aided by the local car buffs who had now formally banded together a few months earlier as the "Bay City Rodders" car club. Many were Seal Beach city employees, including a few policemen and firemen and Jack Osteen of

the Rec Department. Two of the key Rodders were policeman Pat Sullivan and fireman Don Mabe. Sullivan is now retired and lives in Arizona, but Mabe still lives in Seal Beach, and can be frequently found holding court and talking cars and at the Yucatan Grill or Marni's.

"Don and I and George Steele used to meet up at Ascot Raceway in Gardena," recalled Sullivan. "Don and I kept saying we should start a car club. Finally, we did it – and started meeting in the Public Works meeting room and then the police station." It seems the first Seal Beach car show was the catalyst, because the group officially organized in summer 1988.

Both Sullivan and Mabe remember the first car show as kind of loose. "People just parked wherever they wanted," said Sullivan. "But we knew car shows – at least the ones we liked," added Mabe. "So we volunteered and took over the car stuff, assigning the car spots and loading them in an organized manner. Plus, we handled the trophies and awards."

Sullivan said Mabe grew up in the Compton car culture so he knew all those guys growing up, plus he had built a lot of cars for those guys. He built the 1941 Willys that is on display at Rick Lorenzen's Automobilia Museum near the old Lions Dragstrip site in Wilmington.

"We mainly left the applica-

## Planners support Main Street Specific Plan amendment

Proposal would allow some outdoor uses for Main Street

The Planning Commission on April 15 voted 4-1 to recommend that the City Council approve proposed guidelines for business uses for Main Street sidewalks.

District Four Commissioner Patty Campbell cast the dissenting votes. After the meeting, she said she voted no because people didn't support the guidelines as written. During the meeting, Campbell asked the audience how many of them supported the proposal. No hands went up.

However, during the public hearing, Main Street area business owners supported outdoor dining but





tions, sponsors, and admin stuff to French," said Mabe, "and he also got the flyers made up – although we did help distribute them. We'd drop them off at the car events we went to – like the Donut Derelicts who still meet every Saturday Morning at Adam's Donuts in Huntington Beach.

"Next thing we know we're up to 300 cars and it's a great event," said Mabe. "Cars right there on Ocean with the pier in the background and up and down Main Street and Central. On a sunny spring day. And the whole town comes out. It's a big event, but it's also so local. You would run into 100 neighbors and friends whichever way you walked."

1992 saw French leaving to focus on his shows at Belmont Shore, Palm Springs and a new one at the Balboa Pier in Newport Beach. Mabe says the business association asked us to step in "so we basically ran the whole show for a couple years." Part of French's departure was due to a Business Association decision to keep the show as local as possible with only entries from Seal Beach residents or merchants accepted up to a couple months before the event. The number of cars was also limited to 400 and old newspaper photos show they were now lining up cars along the curbs of Main Street, allowing viewers to

stroll down the middle.

Nonetheless, by now the event had gotten so big, the Business Association moved the Sidewalk Sale to March.

Stan Anderson, the owner of Coach's restaurant, became president of the Business Association in 1994, and raved about the Rodders work. "They were great. The Rodders ran the show and we paid the bills and then split the profits. We'd use our profits to fund the Christmas Parade, and the Rodders donated their share to lots of groups around town."

"It was a great arrangement," said Anderson, "until I almost screwed it up. I made the mistake of appointing as co-chair a guy who owned a coffee shop and some property on the 300 block. Well, he thought he was in total charge of the show and came in and told the Rodders that we're going to do things differently and basically wouldn't even talk to them. Or at least that's how they felt. I mean, the Rodders are all great guys. But somehow he ticked them off. So in February 1997, the Rodders President at that time, Bill Barger, tells me 'We love the event, we love the city, but we're not working with this guy. So good luck with the

event but we're out of here."

"Fortunately, I got Dennis Pollman involved and he was able to obtain the mailing list from the Rodders, and Kim and Steve Masoner also stepped in and we salvaged the event that year but it was little rocky for awhile."

The Rodders were gracious in their version of the parting. "We were getting older. It was a good time to move on," said Mabe. "By then we had trained a lot of people on the best way to organize the cars."

Not all of the Rodders got out of the car show business though. Some members continued to help Bob French with his Belmont Shore car shows – which at that time was a spring show at the beach and a fall one at Marine Stadium. After a couple years, French passed away and the Rodders took over the organizing and cut back to just one show a year, in the Fall on Second Street.

Cardiotoxicity is a condition characterized by heart damage resulting from certain cancer treatments including radiation, targeted therapy, and immunotherapy drugs, making it harder for the heart to pump blood throughout the body. Certain types of cancer treatments have a higher risk for cardiotoxicity.

Cardiotoxicity can appear during treatment or even years after remission. Identifying it can be difficult, as its symptoms are often nonspecific, such as fatigue, shortness of breath and may be similar to side effects of chemotherapy, radiation therapy or deconditioning. Because of this, it's key to keep an eye out for anything abnormal or out of the ordinary.

Possible symptoms of heart problems related to cardiotoxicity may include:


- Shortness of breath or dizziness
- Heart palpitations or chest pain
- Swelling and fluid retention in the legs or abdomen
- Loss of endurance or unexplained fatigue Those with a higher risk of cardiotoxicity from cancer treatment include people who:
- Are 65 and older, young children and women
- Received high doses of anthracycline chemotherapy
- Had high-dose radiation therapy to the chest
- Have two or more co-existing cardiovascular risk factors including hypertension, diabetes, hyperlipidemia, obesity or history of smoking
- Already diagnosed with heart disease

While there are no sure-fire ways to eliminate cardiotoxicity, there are advanced technologies for radiation treatment – such as those at the Todd Cancer Institute that use lasers to target locations within micromillimeters of accuracy – that can protect healthy tissue. It's important to learn what capabilities your cancer center has to prevent your heart from this exposure.

Extensive research is underway for ways to detect early cardiotoxicity before injury occurs, and are available now for some cancer therapies. Discuss the pros and cons of these treatments with your doctor to determine if there is a method than can reduce your cardiovascular risk.

They then prioritize the calls based on urgency and dispatch the appropriate emergency services, which may include police, fire, or mediincident, dispatchers maintain ongoing communication with the responding units, providing them additional resources as needed. Their role is vital in coordinating a rapid and effective response, ensuring that help arrives as quickly as possible while also keeping emergency responders informed and safe.



Administration presented to the Board unprepared project, they do not listen to Board Directors and GRF members concerns regarding that unnecessary and very expensive project.

Leisure World was developed in the early 1960s, when Building Codes were different, and traffic at Seal Beach Blvd and Saint Andrews Dr. was much smaller.

Like any project this one must start with Engineering Study, but not with GRF current management. In my comments at GRF Board meeting I said that this Project is going

to repeat mistakes of many past Projects, such as Globe, North Gate, Telecommunication, Street Paving and more. The difference is that all past projects suffered big financial losses paid by GRF members and nobody was held accountable. The current Project, in addition to financial losses, could create a disaster at the Main Gate entrance, at Seal Beach Boulevard traffic and OC and Long Beach Buses traffic.

On April 23, 2023, I sent A Letter to City Seal Beach Manager Jill R. Ingram regarding concern with that project and asked City to request that GRF to comply with Orange County Fire Authority Standard B-09. The requirements are: (quote) "Plans shall be provided to demonstrate compliance with all codes and other regulations governing water availability for firefighting and emergency access".

GRF planned Under the Project to install electronic operated permanent barriers, kiosks, the way vehicles will enter the community to be changed. Will be the new system available to manage existing traffic, are the shapes of turns comply with standards and codes requirements, where unauthorized vehicles will make U-turn, and many more questions must be answered by the Master Plan. It should be

approved by Orange County Fire authority.

In response I received a Letter, dated April 27, 2023, and signed by "GRF Management Team", part of which I would like to quote: "OCFA Fire Marshall Inspectors checked the gates, and they are complaint." I agree with it. Today millions of houses and Master Plans of communities do not in compliance with current codes and Standards, but Building Inspectors and Fire Marshalls will not require homeowners to comply with. Everything will change when you decide to remodel your house or reshape, as in Leisure World, the Gates Entrance System - Compliance with OCFA Standard B-09 will be mandatory.

Only after City Seal Beach Manager request, on July 2023, six months after the Project was approved, the GRF Board hired Urban Crossroad (quote) "to complete a traffic study and provide solutions to the Main gate entry."

This very expensive and dangerous Project must be immediately stopped. Authorities should not wait until accidents take place. The question is not will it happens. The question is when.

coming in slightly stronger than the previous fiscal year at this time, but we do anticipate a few shortfalls in the remaining fiscal year," Arenado

She said overall revenues would come in on budget due to one-time revenues. She also said most of Seal Beach's revenues come in at the second half of the fiscal year.

"General fund revenues consist mostly of property tax sales tax and utility users tax," Arenado said.

"When you include franchise fees, transient occupancy tax, and you add in business licenses, that's 80% of our revenues and 80% of our revenues are based on conditions we cannot control," Arenado said.

"Sales tax and property tax are revenues for the city, but unlike some other income streams the city doesn't have direct control over how much money it receives from them. These taxes are determined by factors like consumer spending and property values, which are influenced by the broader economy and local market conditions," Arenado

"Property tax is the city's largest revenue source, making up 35% of the General Fund and is a stable revenue source at this time," Arenado

She said midyear payments were coming in as expected and staff anticipated hitting budget by year's

#### Sales taxes

She said sales taxes were trending down in the third quarter.

She said that, according to HdL, if the sales tax declines further, staff may need to return to council for further reductions.

"As of now, we have received less revenue than the same time last year. The city sales tax is mostly

consumer goods and casual dining; restaurants and all segments are down besides casual dining," Arenado said.

"Some good news. UUT is 11% of the budget," Arenado said.

"The city is receiving growth in UUTs revenues across all categories, especially in electric," Arenado said.

"For the first half of the year, especially in electric for the first half of the year, we have seen positive gains outpacing assumptions," Arenado said.

"We anticipate this revenue source to be up 600,000 [dollars] from budget assumption," Arenado

She attributed the increase to increasing costs and inflation.

"More good news is transient occupancy tax which is our hotel tax and we are including in midyear a \$200,000 increase to our TOT. The reason is our hotels have surpassed pre-pandemic levels. They've exceeded them. This number could even increase slightly as some of our hotels are sold out in March,"

"This is really good news. We've partnered with them and we've met with each hotel and we're going to be meeting with them on a quarterly basis so we can continue to get information on where we're at, it's really too early to tell as this revenue source is truly highly volatile,

She said the TOT tax was driven by market demand.

Arenado said staff anticipated TOT revenue to be strong through next year, barring any unforeseen economic changes," Arenado said.

She then discussed charges for

"A request is being provided to reduce parking citation revenue by a half a million and this is due first to greater compliance, and that truly is the ultimate goal, for greater compliance," Arenado said.

She also reported on one-time

She started by saying Seal Beach had paid off the fire station bond.

"Part of that bond covenant was to hold a reserve amount of approximately the first year's payment and that is being returned to the city and that amount will be refunded back to the General Fund," Arenado said.

According to her slide, that would be \$659,500.

"Additionally in 22-23 the city had severe atmospheric rivers and the pier was damaged. The repairs were completed and General Fund proceeds were used and the insurance payment has been received," Arenado said.

"Additionally the fire final reimbursement payment for the 2016 pier fire is anticipated to be received by the end of this fiscal year," Arenado said.

Then she turned to expenditures.

According to Arenado, 50% of Seal Beach's expenditures are salaries and benefits, including retirement. She said Seal Beach was lean for a full service city.

"Maintenance and operations constitutes 50% of the General Fund budget," Arenado said.

She said maintenance and operations was expected to be over budget by year's end.

Arenado said departments are expected to stay within their bud-

According to Arenado, Seal Beach doesn't typically have midyear budget adjustments, but there had been so many storms and emergency situations that there were requests for midyear adjustments this year. (Those adjustments were approved last week at the same time the council received the midyear budget review.)

'This year we were under budget primarily due to the city's vacant positions," Arenado said.

There had been a delay in both full time and part time hiring "due to ongoing labor constraints," according to Arenado.

She said overtime was wellmonitored but fluctuates due to unanticipated events.

## Council questions

"What areas are you concerned with the most out of the based on the midterm analysis?" asked District Two Council Member Tom Moore.

"Definitely would be a reduction in our revenues," Arenado said.

"We're seeing over a million in reduction in revenues," Arenado

"Like I mentioned, the citations, parking meters, we're also seeing them in permitting activities," Arenado said.

"After Covid there was a lot of people home and making improvements. Those are no longer happening and so those reductions in revenues will severely impact the budget going forward because that reduces the ability to fund programs and services," Arenado said.

"Are we looking at expenses? What are we doing to reduce expenses?" Moore asked..

Arenado said she, departments, and the city manager, have been looking at line item details in expenditures across the board. She said they were looking at all service contracts.

She said the city was negotiating

"I've negotiated three contracts already for reduction in prices," Arenado said.

"It's a tough market to negotiate a contract less, but that's the goal right now," she said.

She said the goal right now was to preserve what positions the city has because that's how the city provides the services.

Moore said he didn't understand the parking meter revenue.

She explained that \$349,000 was the budgeted amount for parking

The actual amount the prior year was \$210,000.

Arenado said it was dropping. She said she thought the expectation was that Seal Beach was going to receive more money. She also said everything impacts parking in the city along with citations. That included the rain, staff on the meters, and the number of people visiting the beach area.

Moore said Seal Beach made more money with the parking meters versus the pay stations.

According to Arenado, no. She believed the city anticipated more revenue than the city actually received.

Arenado encouraged the public to attend budget workshops when they are held and provide their feed-

District Three Councilwoman Lisa Landau asked when the budget workshops be held.

Arenado said right now staff was looking at May 14 and 15.

District Five Councilman Nathan Steele compared the situation to checking an airplane while it was in the air to see if there was enough fuel in to reach where they were trying to go.

"So it's kind of a forward look here?" he asked.

Arenado said that was correct.

"And right now we're under pressure on revenue items, in general. I think we have one bright spot in ongoing revenue?" Steele asked.

"UUT and TOT are both up," Arenado said.

Steele referred to the five-year outlook that came out in 2023. He asked if that was getting better or

"Due to the reductions in revenues, it's getting worse," Arenado

"What can we do to find new sources of revenue or other cost savings as we go forward?" Steele asked.

"Staff can evaluate programs and services and how we're looking at that and staffing levels and see if we if there's any kind of duplication of services which we're truly not finding," Arenado said.

"But, really, as these mandated costs consume our budget, we really need to look at opportunities for revenues, especially as we do look at the five-year horizon and beyond," Arenado said.

"Expenditures are going to keep going up just like in everybody's household those expenditures keep going up and we need to partner with Council to ensure that we're working in partnership to increase revenues for the fiscal sustainability

"I completely agree, we need to be looking for revenue opportunities. We also need to be watching our operating budget as closely as we can. I know you're going through the budgeting process right now for our next year's operating budget. How is that going? Is it a moving target, is it hard to meet, are we going to make it?" Steele asked.

"Well I have to say you have an excellent team out here that I've been partnering with every day. I've talked to several of the staff," Arenado said.

She said staff talk all weekend and work through questions and thought processes on how they can balance the budget.

"Right now, we do have a gap and we're working to close that as much as we can," Arenado said.

She said that the city had \$1 million less revenue in just one category of charges for services.

"How can we educate the public about this stuff?" Steele asked.

"Communication is key," Arenado said.

She said the May budget workshops would be an excellent opportunity to ask questions.

Arenado said the budget workshops would be long.

District Four Council Member/ Mayor Schelly Sustarsic said she had a question about the parking revenue being down.

"I'm wondering about our expectations for the nighttime hours it seems to me that the cars that are there are mostly going to stay there. Did we overestimate that or is it something else I'm not understanding?" Sustarsic asked.

Seal Beach Police Chief Michael Henderson said that what they were finding is that they are achieving compliance. Henderson said that sometimes results in lower reve-

Sustarsic turned to the budget amendment. She said she was concerned about the McGaugh Pool and having revenue available for its upkeep "to try to drag out its years."

She expressed concern that an unexpected event could force what she called a premature shutdown of the pool. "I'd just like to see the pool continue for as long as we can keep it," Sustarsic said.

City Manager Ingram staf staff would continue through the annual budget process for ongoing maintenance of the pool. Ingram said in the event of something unforeseen, staff would come back to the council for discussion and a budget amendment.

District One Council Member Joe Kalmick asked if there was a horizon on rates for the beach parking lot. "And if we do finally get Coastal Commission approval, do we have any kind of back of the envelop projection of what we might generate in revenue from those increases?" Kalmick asked.

Henderson said the application to increase beach parking rates had been submitted to the Coastal Commission. Henderson said city staff had set up a meeting to discuss it with Coastal Commission staff, but said the process might take some time.



## **SBPD** officers use Narcan to save a life

The Seal Beach Police Department responded to an opioid overdose incident and administered Narcan to save a life, according to a statement issued on Monday, April 15. "This incident highlights the critical role of Narcan in saving lives during opioid overdoses, particularly with the prevalence of dangerous substances like fentanyl," said Seal Beach Chief of Police Michael Henderson. "We are grateful for the swift response of our officers and the collaboration with OCFA in providing immediate medical assistance."

On Thursday March 7, at approximately 12:42 p.m., the Seal Beach Police Department responded to a report of a suspicious vehicle in the 100 block of 14th Street in Seal Beach. The caller described a black Ford Excursion with a male driver appearing to be slumped over the steering wheel and another individual possibly unconscious in the back.

Upon arrival, officers encountered a black F-250 with a camper shell, with the engine running. A man standing outside the vehicle informed officers that his friend was inside sleeping. When approached, the individual said his friend had a history of narcotics use. An officer checked on the individual's welfare and found him unconscious but breathing inside the running vehicle. Despite attempts to wake the man, the individual remained unresponsive.

Based on his training and experience, the officer recognized the signs and symptoms of an opioid overdose and immediately got a Narcan 4mg nasal dose emergency opioid treatment from his patrol vehicle. The officer administered the Narcan into the subject's left nostril. After about 20 seconds, the subject regained consciousness.

After regaining consciousness, the individual was assessed by Orange County Fire Authority paramedics. The officer assisted in contacting the individual's family members and remained on scene to monitor his wellbeing and ensure his safety until family members arrived to transport him to a local hospital.

caller for help for retailers.

The proposed Outdoor Uses Program would require an amendment to the Main Street Specific Plan. Only the council can amend the Specific Plan.

The commissioners discussed a further look at the 8-foot clearance requirement. Community Development Director Alexa Smittle acknowledged that the space would be an issue for some loca-

tions. She said there was another pathway depending on the permit being applied for.

District Three Commissioner/ Chair Richard Coles initially proposed continuing the hearing for further discussion, but ultimately joined the vote approving the proposed program.

District Five Commissioner Margo Wheeler wanted an opportunity for retailers to have outdoor displays.

The commission did include some changes in their recommendation:

• The proposed program needed to bolster revocation of a permit

- · Merchandise should be the same standards as dining
- Ensure maintenance of the outdoor uses

## **Background**

(MSSP) adopted by the City Council on July 8, 1996 serves as a comprehensive regulatory framework guiding land use and development within the Main Street area of the city," according to the staff report prepared

Coats and Community Development Director Alexa Smittle.

The report said the proposed Specific Plan amendment would streamline the process for such sidewalk uses as "potted plants, A-frame signs, or small dining tables," that are currently allowed in other ways.

"This item proposes an amendment to the MSSP that would allow for an expansion of certain uses into the public right-of-way through an administrative permit process, including small-scale outdoor dining," according to the staff report. (For details, see "Planners to look

at Outdoor uses on Main Street," at sunnews.org.)

"The installation of the counter at Marina Café roughly a year ago through a Minor Use Permit has attracted users and it has been reported to staff that the addition invigorated sales for the business," according to the staff report.

The proposal would require an 8-foot clearance on the sidewalk.

Merchandise displays would require a Minor Use Permit or a Conditional Use Permit, according to the draft of the Main Street Outdoor Uses Guide.

During the meeting, Management Analyst Coats said the proposed administrative review did not include outside display of merchan-

"However, the option to display merchandise outside, within private property boundaries will remain possible through the discretionary review and approval of the Planning Commission," Coats said.

She said outside display of merchandise on the sidewalk will still be allowed during approved special events.

## **Before the hearing**

Before the public comment part of the commission meeting, Deputy City Clerk Brandon DeCriscio said he didn't have any completed speaker cards.

Rob Jahncke, owner of Javatinis Espresso, said the Outdoor Uses Plan was going in the right direction. "Anything that will enhance downtown, I think, will bring more people downtown, and I like the direction it's going," Jahncke said.

He said he had concerns about details.

"For example, I'm on Central and Main Street," Jahncke said. "So you guys have a bench that is 6-anda-half feet from my wall that doesn't even fit the 8-foot rule."

Jahncke suggested a case-bycase look at sidewalk clearance.

He said he had tables and chairs that were carried over from the COVID pandemic and they have been popular.

Jahncke was curious about the

District Three Commissioner/ Chair Richard Coles said they hadn't passed the resolution yet, so that was still under consideration.

(Page 10 of the draft of the proposed guidelines says applicants for the Main Street Dining Permit

would have to pay a fee every year.) He said Main Street was not healthy right now. "It's tough out there right now," Jahncke said.

Assistant City Attorney Amy Greyson said if people had comments on the Specific Plan Amendment, they should make those comments during the public hearing on that issue.

Coles agreed. "This is for general comments," Coles said.

Later, before the public hearing was opened for comment, District Two Commissioner Ben Wong, asked if there had been any thoughts about placing bollards in front of tables near the curb in case of a car accident or someone accelerating accidentally.

Planning Manager Shaun Temple said the city does not allow anything placed within two feet of the curb.

Wong asked if there would be a review if restaurants submitted an application for outdoor dining.

Temple said they would have to submit a site plan. "We'd have to review for those standards," Temple

According to Smittle, if an applicant's plan didn't meet the standard. they would be rejected from this process "It remains open to businesses to go through the process that exists today, which is to obtain a minor use permit or a conditional use permit, depending on what their request is," Smittle said.

"Is there a strong argument on why clothing racks wouldn't be permitted?" Wong asked.

Temple said it was easier to create standards for chairs, tables, and potted plants.

According to Temple, there's such a variety of merchandise that it's difficult to create objective standards.

Coles said he was not a big fan of A frame signage. Coles also called for "teeth" in the ordinance. He suggested that a second violation would cost a business their permit.

"Will alcohol be served in these areas?" Coles asked.

"Generally speaking, if alcohol is to be served there needs to be fencing or some sort of barrier erected, which in most cases wouldn't fit to keep that 8-foot distance," Smittle said.

#### **Comments**

In all, 11 members of the public spoke to the issue. Most favored allowing retail displays. One, however, argued that the issue was the need for beautification of Main Street. Matthew Terry said the biggest issue is cutting retail out of the outdoor use program. "I really think retail needs an opportunity to be part of this program as well," he said. Terry said there was an opportunity to simplify the program.

He said memorial benches on Main Street weren't the best idea.

Business owner Jim Watson complimented staff for bringing the program forward. "Almost all successful downtowns, without any exception, provide outside seating," Watson said.

He said outside dining would provide additional customers for retailers and sales tax for the city.

He said Ocean Avenue and Central Avenue should be included in the program.

Watson said the 8-foot clearance would restrict seating and reduce sales tax revenues for Seal Beach.

Frank Ryan said he owned a store on Main Street. He said he was all for more business on Main Street, but this plan left out the retail stores.

He proposed allowing merchandise displays. "Otherwise, you're only helping out the restaurants, really," he said.

Joseph Kirolos, owner of the Marina Café, said he believed he was the only one who was approved for outside tables in 2023. He said he had no complaints. He argued that outdoor seating increased his business

Coles said this is intended to be an incremental approach to defining what the city was doing on Main Street.

shore infrastructure is vital for the warfighting readiness of the Surface Force and our Navy."

The old ammunition wharf was only able to support one destroyersized ship at a time. The new pier will allow dual ship operations and support much larger vessels. "Our new LHD and LHA capabilities will be significant," said Roosevelt Simmons, executive director of Navy Munitions Command Pacific. CONUS West Division Unit Seal Beach.

"The planning process for this project started back in 2011, with construction starting at the end of 2019," said Jazmin Atencia, station Plans, Programs & Readiness Integrator. "All construction should be completed by this summer."

# City to submit Housing Element draft to state

Seal Beach will submit the new draft of the Housing Element to the state by the end of this week, according to Community Development Director Alexa Smittle.

As previously reported, changes to the Housing Element will require citywide

changes to to the Zoning Code. According to the draft of the Housing Element, the city will "[u]pdate Main Street Specific Plan as described by October 2024."

The new draft of the Housing Element is available for public review on the city website. According to the draft, the city plans at least one meeting on the Zoning Code and General Plan by October 2024.

The city plans to change the Zoning Code for accessory dwelling units by Sept. 2024.

Pre-approved Accessory Dwelling Unit plans would be dropped by September 2024.

The state has mandated that Seal Beach plan for 1,243 residential units.
